

CULTURAL KEYS' RELEASE OF LIABILITY

Chaoyang District, Sanlitun SOHO, Building A, 11th Floor, Room A1127 Beijing, China, and/or use of the property, facilities and services of Cultural Keys & CK Martial Hearts, I, _____, on _____, agree to the following:

1. AGREEMENT TO FOLLOW DIRECTIONS. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Cultural Keys & CK Martial Hearts, or the employees, representatives or agents of Cultural Keys & CK Martial Hearts.

2. ASSUMPTION OF THE RISKS AND RELEASE. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge Cultural Keys & CK Martial Hearts for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of Cultural Keys & CK Martial Hearts, whether caused by the fault of myself, my family, Cultural Keys & CK Martial Hearts or other third parties.

3. INDEMNIFICATION. I agree to indemnify and defend Cultural Keys & CK Martial Hearts against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the facilities of Cultural Keys & CK Martial Hearts.

4. FEES. I agree to pay for all damages to the facilities of Cultural Keys & CK Martial Hearts caused by any negligent, reckless, or willful actions by me or my family.

5. APPLICABLE LAW. Any legal or equitable claim that may arise from participation in the above shall be resolved under Chinese law.

6. NO DURESS. I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this Agreement if I so desire.

7. ARM'S LENGTH AGREEMENT. This Agreement and each of its terms are the product of an arms' length negotiation between the Parties. In the event any ambiguity is found to exist in the interpretation of this Agreement, or any of its provisions, the Parties, and each of them, explicitly reject the application of any legal or equitable rule of interpretation which would lead to a construction either "for" or "against" a particular party based upon their status as the drafter of a specific term, language, or provision giving rise to such ambiguity.

8. ENFORCEABILITY. The invalidity or unenforceability of any provision of this Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of this Agreement or of any other applications of such provision, as the case may be, and such invalid or unenforceable provision shall be deemed not to be a part of this Agreement.

9. INSURANCE. Cultural Keys and CK Martial Hearts have made clear the importance of Medical and Travel Insurance, and I have accepted that I will bear full responsibility, either out-of-pocket or through insurance policy coverage, for any costs arising from any accident or sickness I endure during the course of the CK Martial Hearts kung fu training programs.
